b. President's Evaluation Schedule Doc: 47 - FY2017

The President Evaluation Schedule has been moved out from early summer to September and October 2017 due to the data needed to support/report on the joint goals set at the start of FY2017. Vice President Wallis will be in touch with the evaluation committee with further info and meeting dates. Committee members are Chair LaRock, Vice Chair Hogan (if not replaced with new appointed Trustee), Trustee Riley and Trustee Kaplan.

c. Alumni Elected Trustee Notification - Alex Stone

President Gentile notified the Trustees that Alex Stone '11 has been elected by the Alumni Association to serve as the Elected Alumni Trustee for a 5 year term. He has a robust interest in North Shore Community College, is mission driven and will bring a new perspective to the board. He is currently Founder & CEO of Athletes of Valor, an organization that supports transitioning military from service to career by leveraging collegiate sports.

Board of Higher Ed Meeting Update

Chair LaRock reported that the BHE Board approved selection decision by the SSU Board of Trustees for the next President of SSU, John Keenan. Though a bit controversial, the BHE Board voted unanimously to approve this decision.

5. President's Report

- a. NSCC Foundation FY18 Goals & Advancement Update
 - VSE Outcomes Doc 46 FY2017

President Gentile presented a powerpoint report that was recently shared and discussed at the Foundation Board meeting: **Annual Analysis of Outcomes Fundraising Report 2016**

The President updated the Trustees on the goals of the Foundation, Inc. She reviewed national, regional and college foundation data on fundraising contributions and endowment. The VSE provides benchmark data for public community colleges. This report was discussed with the Foundation Board and the following outcomes were approved from the report:

- We are reflective of our peer MA community college, but below the national mean for voluntary giving to public community colleges;
- Sources of giving are comparable to national mean but we could grow our corporate giving;
- We are staying within a fairly fixed range of giving and not showing long term growth yet;

- We need to continue to build our endowment which will include a 5-year fundraising plan.
- b. Event Update Nicole Marcotte, Development Director

Nicole Marcotte, Development Director thanked the Board for time to discuss the upcoming events and strategy for fundraising efforts to grow the Foundation endowment.

- September 15, 2017 Ribbon Cutting Lynn Expansion (7:30am coffee with program 8:00am 9:30am) where we will unveil a donor wall.
- October 3, 2017 Breakfast Together NSCC Advances: Champions for North Shore Community College as the first of an annual event honoring donor and/or support of NSCC in the categories of individual donor, corporate donor, and public service. This event will target corporate sponsors/donors.
- The North Shore Advancing campaign will continue to move forward but as a major gifts initiative.

There was a brief discussion on Trustee giving with Chair LaRock noting that the Board can move forward with individual giving or can donate as a group as with their yearly Scholarship initiative.

c. Program Review Update - Karen Hynick, Vice President Academic Affairs Doc: 43 - FY2017

Outcomes of 2016 - 2017 Program Review

Vice President Karen Hynick provided update on NSCC's Academic Program Review. This is a 5 year cycle for programs using both quantitative and qualitative metrics that are analyzed and reviewed by current faculty. This year there were 19 programs reviewed. Key takeaways:

- Planning for program closures of Food Science, Hospitality & Tourism, ESL Certificate, Interdisciplinary Studies, and Web Development Certificate;
- Faculty buy-in and engagement in the process;
- Strengthened institutional programmatic understanding of our offerings; and
- Alignment to strategic plan and academic plan.

Next year 18 programs will go through the program review process.

There was a discussion on the uniqueness of some of NSCC's programs, delivery of on-line courses and the plan to move more programs to hybrid courses that will work around students' schedules and responsibilities. Vice President Hynick noted that there is strategic movement in this direction.

• Motion 17:24 - to approve recommendation to the Board of Higher Education the Associate of Applied Science (AAS), Surgical Technology Program - Doc: 44 - FY2017

Changing the Surgical Technology Program from a certificate program to a full Associates of Applied Science was explained by Vice President Hynick. The Board discussed rationale. The next steps are for the NSCC Board of Trustees to recommend the formal approval of this program to the Department of Higher Education.
