	1. <b>Mandatory Information Session Attendance</b> Applicants must attend a Mandatory Information Session during the academic year prior to admission (after August, 2024). Upcoming dates are available by visiting: <b>northshore.edu/academics/programs/ota/mandatory-info-sessions.html</b> Attendance will be recorded.			
	2. <b>NSCC Application for Admission</b> Complete the <b>application</b> for the year for which you are applying; regardless of whether you are a new or current student (a previously submitted application does not count). You must indicate if you are applying for the <b>traditional option of study</b> or the <b>accelerated option of study</b> .			
	3. <b>TEAS Exam</b> The preferred site for the ATI TEAS exam is North Shore Community College. Online TEAS exams are not accepted at this time. Students must take the ATI TEAS Version 7. Students whose score reports reflect that they have tested more than two times or at another location other than NSCC must also submit an official TEAS transcript from ATI: https://atitesting.com/ati_store/ Additional charges may apply. 	NSCC reserves the right to verify all TEAS score reports for exams taken in testing locations other than NSCC. Exams taken at locations other than NSCC must adhere to proctoring requirements with a secured browser. <b>TEAS@northshore.edu</b>			
	Applicants are limited to three attempts within a year (September 1 - August 31), regardless of the testing site and program to which they are applying.			
	Each of the following sections are required to be taken: Reading; Math; Science; and English - and all scores will be included in the review process. <b>A minimum score of 69% in Reading must be achieved in order to apply</b>			
	<b>EXEMPTION:</b> Applicants who have earned a Bachelor's Degree from an academic institution accredited by a regional or national accrediting agency recognized by the U.S. Department of Education, AND have completed both Anatomy & Physiology 1 and 2 with a "C" grade or better will have the TEAS requirement waived.			
	<ol> <li>Essay         A word-processed essay written in the English language must be submitted for the year in which you are applying. (Essay must be typed and only 1 page in length). Grammar and spelling are considered in addition to content and quality of your essay.     </li> </ol>

	5. Accelerated Option of Study Course Reference Form If you indicated that you wish to apply for the OTA accelerated option of study, you will need to meet all 6 pre-admission courses by the end of summer session 1 2025 [Composition 1 [CMP101]; Composition 2 elective [CMP102 – 150]; General Psychology [PSY102]; Human Growth and Development [PSY204]; Anatomy & Physiology 1 [BIO 211] and Anatomy & Physiology 2 [BIO212]. You will need to complete the attached Course Reference Form indicating when each course was successfully completed or when you intend to take the required course(s) as well as the academic institution where course(s) were completed or anticipated completion date
