| Rabies Pre-<br>Exposure<br>Vaccination<br><b>Requirement</b> | <ul> <li>The Rabies pre-exposure vaccination series <i>DOES NOT</i> have to be completed prior to submitting an APPLICATION to the program. Once accepted: <ol> <li>Students using personal health insurance need to demonstrate they have started the series by submitting documentation with their health packet due date in July 2022 (date TBD). Documentation that the series is completed needs to be submitted no later than August 2022 (date TBD) prior to starting classes in the fall.</li> <li>OR</li> <li>Students with health insurance through NSCC will have until October 2022 (date TBD) to complete the vaccination series and submit documentation.</li> <li>OR</li> <li>Students that have completed their pre- exposure Rabies vaccine series greater than 2 years from when starting the program must submit a titer level for the vaccine with their health packet in July 2022 (date TBD). If you have had a titer done within 1 year of starting the program, please submit the results with your health packet.</li> <li>A veterinary technology student who is in contact with patients may be exempt from the Rabies pre-exposure immunization requirement due to a medical or religious exemption. Submission of documentation will be required and, if sufficient to qualify for a medical or religious exemption, it will be granted. Failure to complete pre-exposure Rabies vaccination may impact or prevent a student from participating in a Service Learning component of a class.</li> <li>Information on where to obtain the Rabies pre-exposure vaccination series is available at the Mandatory Information Sessions and will be given out at orientation (May 2022, TBD). Information on financial assistance available through the college to aid in offsetting the cost of the Rabies pre-exposure vaccination series is available to qualified students once accepted into the program.</li> </ol> </li> </ul> |
